In addition, the transfer release date must be reached before Loyola can issue the Form I-20.

F-1 students must arrange for a transfer of their SEVIS record within 60 days following successful completion of a program of study at another university, or within 60 days following an authorized period of Optional Practical Training.

Also, please note, that if you depart the U.S. during this transfer period, you must use the Loyola-issued Form I-20 to re-enter the U.S.
