Documentation Required for International Applicants Requesting F-1 Student Status

- International Student Supplemental Application:** Required for United States Immigration purposes.
- TOEFL or IELTS Score Report:** Required if English is not your native language. Send unofficial scores with application. TOEFL or IELTS scores must be from tests administered within two years of the application deadline. Official scores must be sent directly from the testing agency. Loyola's institution code is 5370.
- Passport Copy:** Submit a copy of the biographical page of the student's passport.
- Transcript Credential Evaluation:** Loyola recommends WES.org or NACES.org.

Required Materials to Finalize Admission

International applicants who are offered admission must follow the steps listed below before a Form I-20 can be issued:

- *Current Bank Letter:** Verifying that funds are available to support your stay at Loyola which must be accompanied by a current bank statement issued within month of submitting your application (in U.S. dollars). The bank letter must be on bank stationery, in English, and signed by a bank official with contact information. The bank letter or statement must be an original document and must be mailed to Loyola. Photocopies and scanned documents will NOT be accepted.
- *Declaration of Finances Form:** Verifying that funds are available to support your stay at Loyola and must be accompanied by a current bank statement issued within one month of applying (in U.S. dollars).
- *Affidavit of Financial Support:** Form affirming that all expenses will be met during your period of enrollment at Loyola. Expenses include tuition, fees, books, housing, medical, and all other living expenses (in U.S. dollars).
- Proof of Health Insurance:** Proof of coverage for the duration of study at Loyola (must be renewed each academic year). The coverage must be equivalent to Loyola's health insurance plan administered by United Healthcare Insurance. In addition, the plan must be transferable to the United States.
- Tuition Payment:** Tuition payment for the first 9 credits.
- International Graduate Student Checklist:** Please include this form when you submit your application.
