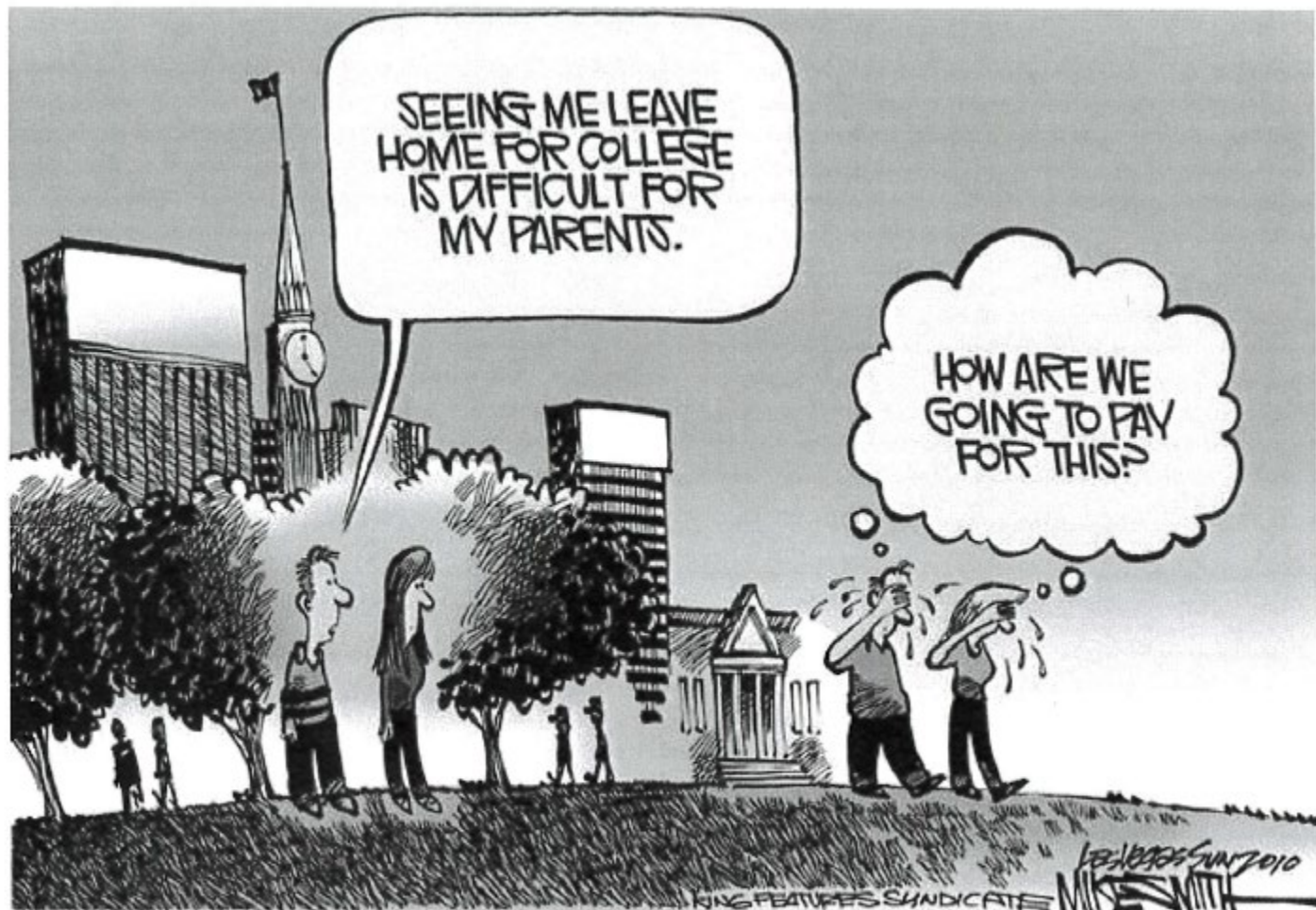

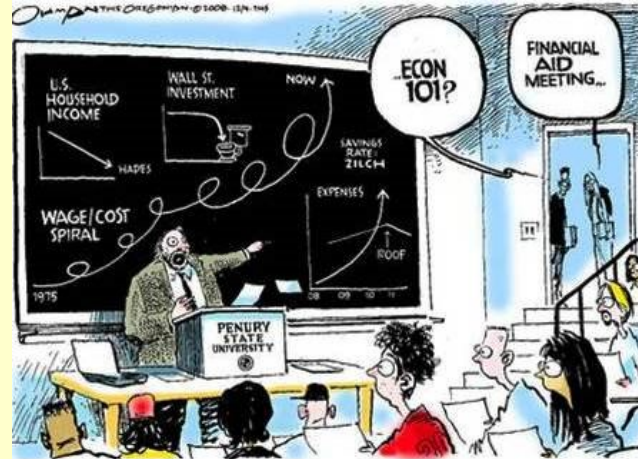

Verification

Loan Procedures

1. Federal Direct Stafford Loan
 - Subsidized & Unsubsidized
2. Loyola Student Loan
3. Federal Direct Parent Loan (PLUS)
4. Private Student Loans



Federal Direct Stafford Loans

Subsidized Loan

- Eligibility is based on demonstrated need
- \$3,500 freshman year
- 1.066% origination fee
- 4.53% interest rate (7/1/19)
- Interest benefit – Federal Government pays interest while in school

Unsubsidized Loan

- Eligibility is not based on financial need
- \$2,000 freshman year
- 1.066% origination fee
- 4.53% interest rate (7/1/19)
- No interest benefit – borrower is responsible for paying all interest

Federal Direct Parent Loan (PLUS)

- Available to parents of dependent undergraduate students
- Parent may not have adverse credit history
- 4.264% origination fee
- 7.08% interest rate (7/1/19)
- Interest accrual begins on the date of the first disbursement
- Repayment begins 60 days after the second disbursement; repayment deferral option available
- Student **must** file 2019-20 FAFSA
- Best if student exhausts eligibility for Direct Loans first; lower interest rates and fees

How To Create An FSA ID

Private Student Loans

- aka Alternative Student Loans
- Non-federal education loans
- Made by banks, credit unions, etc.
- Interest rates, fees and other terms set by the lender, not the federal government
- May require a cosigner
- Will probably have to be school certified – the lender will confirm with Loyola the student is enrolled and eligible to receive a private student loan
- Detailed information is available on the Loyola Office of Financial Aid website


Federal Work-Study (FWS)

- Provides on-campus employment in administrative and academic departments
 - 10 to 15 hours per week
- Minimum hourly wage rate currently \$10.10 (*Increases to \$11.00 on January 1, 2020*)
- FWS Employment Information (August via email)
 - Job listings (departments, job descriptions, contacts)
 - Payroll procedures (employment agreement, tax forms, direct deposit, etc.)
 - FWS Manual (terms and conditions)

Undergraduate Financial Aid



Loyola believes that the cost of a high-quality education should not be a deterrent to prospective applicants. In recognition of the concern students and families have with finding adequate resources to meet these costs, our financial aid program is designed to make Loyola affordable to those students we admit. Approximately 70 percent of all undergraduates receive some form of aid from federal, state, institutional and private sources.

Loyola is willing to share the financial responsibilities of attending college with students and their parents, but we expect the primary or maximum effort to pay for college to come from students and their families. The system used to determine the family's ability to pay contains the following assumptions:

- To the extent they are able, parents have the primary responsibility to pay for their children's education.

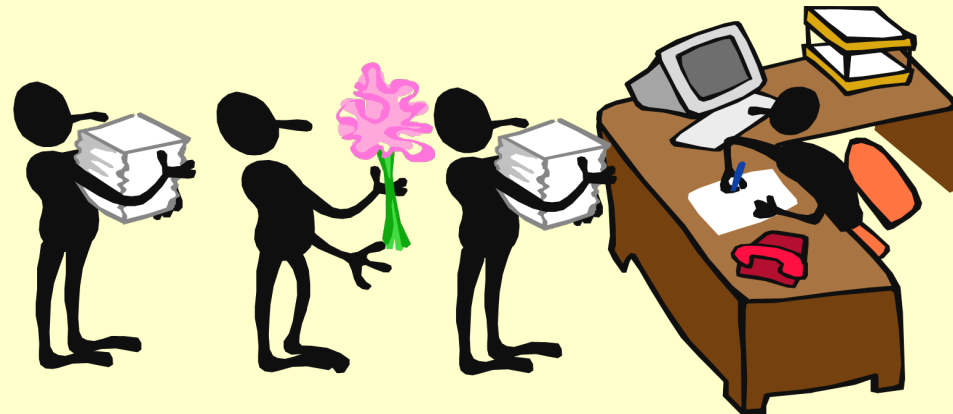

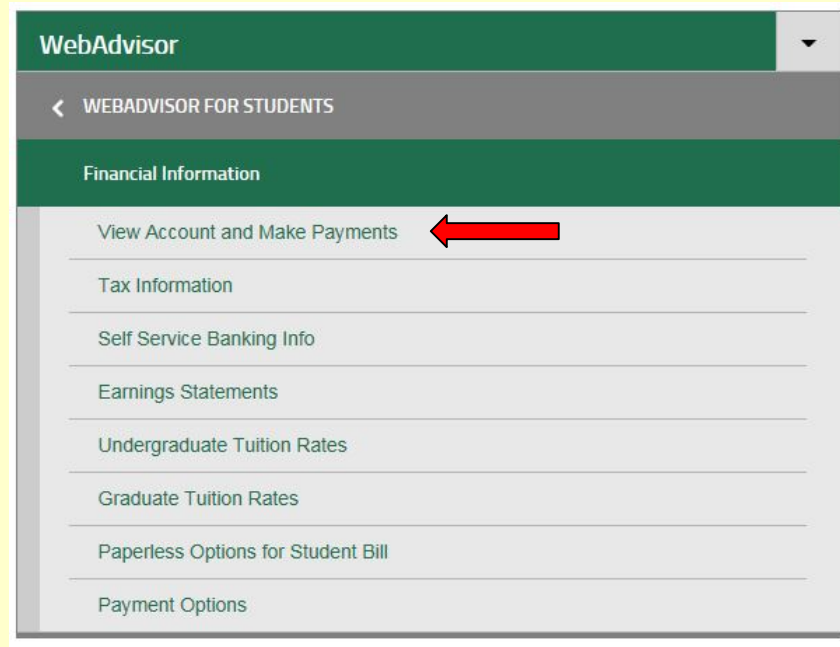

was originated by A.W.G. Dewar in 1930 to protect the financial investments of students and parents in education. Today, more than 1,200 leading independent schools and colleges throughout North America offer the Plan. Because the cost of education today is a substantial investment, in fact, one which is likely to be your second largest next to a home purchase, the protection afforded by the Tuition Refund Plan is essential.

While most colleges provide partial refunds for student withdrawals, they are limited and usually effective when a student withdraws early in the term. The Tuition Refund Plan dramatically enhances the college refund schedule and provides more generous refunds throughout the entire term. Subject to the program terms and conditions, the Tuition Refund Plan offers a refund of term tuition and fees when you are forced to withdraw for medical reasons.

Q. What Is Covered?

A. The Tuition Refund Plan covers the following:

- Injury and Sickness Withdrawals
80% of the insured term tuition, fees and room, less any refund or credit due you from the college, will be refunded provided your physical condition is certified by a licensed physician and forces you to completely withdraw from all classes for the balance of the term.
- Mental Health Withdrawals
80% of the insured term tuition, fees and room, less any refund or credit due you from the college, will be refunded provided your medical condition is certified by a licensed physician and you have completely withdrawn from all classes for a condition whose diagnosis is found in the DSM-V Manual.

In both cases a "complete withdrawal" from the college is required. This means the student has given written notice that due to an injury or sickness he/she will not be able to complete the term and will not receive any academic credit. A written statement from a doctor certifying the injury or sickness and college verification is required. All mental health withdrawals will be classified in accordance with the American Psychiatric Association's Diagnostic and Statistical Manual DSM-V.

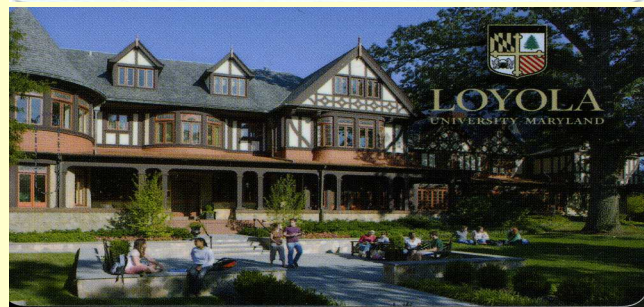

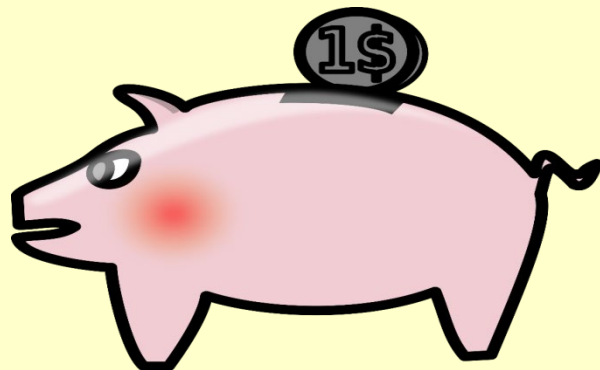
