

#### **NEW UNIFORM GUIDANCE NOW IN PLACE**

In an effort to create a government that is more "efficient, effective, and transparent," the Office of Management and Budget (OMB) released a new rule, called the Uniform Guidance. The Uniform Guidance modifies the way federal agencies manage grants and implements new rules for awards made after December 26, 2014.

You may wonder why the feds have spent much time and energy revamping their guidance for the management of awards and how it affects you. The OMB listened to feedback from the grants community that managing awards was far too onerous. Essentially, the OMB has now streamlined many rules into one document, the main goal of which is to reduce administrative burden. These changes should allow for faculty members to spend more time on research and program implementation and less time on grants administration.

The ORSP and the Controller's Office will be working jointly to implement new changes which will impact areas such as cost allowability and procurement in particular.

There are also some positive changes we wish to highlight. **Funding opportunity announcements,** in most cases, must now be published in a standard format and made available at least 60 days prior to the proposal due date. Additionally, in most cases **voluntary cost sharing** is not permitted and may not be considered. It is important to note, however, that mandatory cost sharing is still permissible.

The ORSP is always available to answer questions and assist as you prepare your grant proposals and after you receive your award. We will continue to provide you with updates on the Uniform Guidance.

### INSTITUTIONAL REVIEW BOARD - NEW FAQ'S

When conducting research that involves the use of human subjects, questions are inevitable. In an effort to answer some of the more commonly asked questions, we have created an FAQ page on the IRB website found at **www.loyola.edu/irb**. The FAQ page provides a quick go-to that will likely answer your question before you spend time reading through the policies and procedures. Below are answers to some common questions that have recently been added to the FAQ page. You may wish to relay this information to your students, especially if you are serving as faculty mentor on a research project that involves human subjects. ### Record-keeping

## Once my research has ended, do I have to keep any paperwork?

Researchers are required to retain copies of documents related to the use of human participants in their research project for a minimum of three years after the completion of the research.

### What if I graduate or leave Loyola before the three-year period is over?

If you are a student, all records must be provided to your faculty sponsor. If you are a Loyola employee, all records must be provided to your department so that they can be retained for the required three-year period.

### **Working with researchers from other institutions**

If a PI is working with data obtained by another institution, does he/she need to obtain IRB approval to use it for his/her research, even if approval was obtained to gather the data by the other university?

If a Loyola faculty member, student, or other member of the Loyola community is planning to analyze data involving human subjects obtained from another institution, he/she must obtain approval from Loyola's IRB before beginning the data analysis. This approval must be obtained even if another institution has given IRB approval for the study.

# If a researcher from another college, university, or organization wants to collect data or recruit subjects on campus, does he/she need IRB approval?

Yes, the IRB must review and approve all proposed data collection or recruitment of human subjects on the Loyola campus prior to a researcher initiating the data collection or subject recruitment on campus.

#### Forms

#### When do I use a request for amendment form?

When a researcher wishes to make changes to a research protocol that has already been reviewed and approved by the IRB, a **request for amendment form** must be submitted to the IRB for review and approval before the proposed changes are implemented. The amendment request must include a detailed description of the proposed changes and all revised documents reflecting the proposed changes.

### When do I use a request for renewal form?

All IRB approvals for expedited and full-review applications are valid for one year. If the research activity extends beyond one year, the researcher is required to submit a **request for renewal form** no less than three weeks prior to the expiration of the approved period. If the approval expires before a renewal request is approved, all research must cease, including any manipulation of collected data.

# Using Social Media to Understand and Address Substance Use and Addiction (R21)

Supports research investigating the role of social media in risk behaviors associated with the use and abuse of alcohol, tobacco, and other drugs and projects using social media to ameliorate such behaviors. Projects must be focused on either observational research using social media interactions as surveillance tools to aid in the understanding of the epidemiology, risk factors, attitudes, and behaviors associated with use and addiction, or intervention research measuring the reach, engagement, and behavioral and health impact of social media-based interventions for the screening, prevention, and treatment, of use and addiction.
