How the Bible's Meaning Changes: Argument and Controversy in the Christian Church. To be submitted to Oxford University Press. 47 ms. pp.

This book project represents a follow up to *Arguing over Texts* by using the classical rhetorical classification of interpretive debates to identify and analyze patterns of argument in a selection of key, historical biblical disputes in Christianity. In each of these disputes, some segment of the church completely reversed its position on the issue. The controversies explored are those over usury, heliocentricity, women's preaching, racial equality, and homosexuality.

This book chapter surveys the linguistic features of any text that can be employed as evidence to support a claim about that text's meaning. The chapter divides these language features into three categories--words, sentences, and passages—and explores how manuscript issues, authorial intention, and audience inference interface with these elements. Interpretations of the Declaration of Independence serve to illustrate how these features work in real hermeneutical arguments.

This book chapter traces the interpretive arguments in Supreme Court Justice Anthony Kennedy's opinions that have expanded legal rights for LGBTQ people. Using the interpretive stases, this chapter identifies key hermeneutical issues upon which Kennedy's readings of the Constitution hinge. The insights of this analysis will provide a road map for arguing constitutional rights into existence as well as reveal potential weaknesses in Kennedy's arguments that leave LGBTQ rights vulnerable to future challenge and rescission.
