# **Guide for Supporting Students in Distress Who are Studying Remotely**

#### **Challenges of Distance Learning**

- Isolation
- Frustration
- Anxiety
- Confusion
- Scarcity of Resources
- Fluid Nature of Decisions
- Multiple External Stressors

#### Physical Illness Signs of Students Experiencing Distress in the Remote Classroom

- References to suicide or self-harm (written or verbal)
- Noted isolation from friends, family, or support persons.
- Drastic change in physical presentation
- Signs of injury to oneself, which could include cuts or bruises.
- Disclosures of anxiety, depression, and stress
- Marked change in behavior, mood, or relationships.
- Impaired speech, garbled, disjointed thoughts.
- Elevated levels of irritability, unruly or abusive behavior
- Appearing overly nervous, tense, or tearful
- Struggling to make decision.
- Drug and alcohol abuse
- Threats to others
- Excessive messaging
- Obsessive behavior
- Observed behavior that is markedly different from their usual presentation when accessing learning management system (not logging in, posting comments that do not address discussion prompt etc.
- Lack of response to messaging or assignment submissions
- Bizarre, paranoid, or confused posting
- Acting erratically as observed by either speaking in a way or at a volume that is incongruent with expectations and norms presented in the class.
- Decreased quality of work
- Displays of firearms or weapons

#### General Tips for Supporting Students through the Transition to Remote Learning

- Take time to review and learn the different resources available to students remotely
- Offer support and expressions of hope.
- Create clear channels for communication and emphasize them to your students
- Be transparent about the issues of transitioning courses and be patient with students through the transition

- Recognize that each student's situation is different and emphasize a willingness to work with students
- Let students know that you want to see them succeed.
- Promote and practice self-care
- It is especially important to be attentive to compassion fatigue and model balance to students.

#### How to Respond and Make a Referral

It is important to realize that when working with a student in distress, there is no such thing as a perfect formula. We all have different abilities and capacities, so it is important to be mindful of your own. Consider the following when supporting students:

- Remember you are not alone. Contact the Counseling Center (410-617-2273 Monday-Friday, 8:30am-5:00 pm) for consultation. You will be connected with a counselor to discuss your concerns and develop a plan to support the student.
- If you believe that a student is a threat to themselves, or others immediately contact Campus Police or 911. Campus Police can readily identify the student's permanent address and emergency contacts.
- Maintain clear and consistent expectations. Given the transition to the remote classroom experience, it is important to re-emphasize and have honest conversations with your students about your expectations. It is entirely possible that some expectations will change. Do your best to communicate this as clearly as possible.
- Talk to the student individually. If you need to address the behavior in front of others, do your best to be respectful, non-judgmental, clear, and to follow up with the student after the interaction.
- Listen to the students' concerns in a sensitive manner and be thoughtful to offer objective critiques, when necessary.
- Share your hope and desire that the situation improves.
- Schedule a time to do a follow-up with the student to discuss progress and provide additional clarification.
- Refer the student to additional support using the resource guide below.

## **Connecting with Supportive Resources on Campus**

A supportive conversation with a student that is struggling can go a long way in helping them achieve success at Loyola. The goal is not to solve problems, but to provide caring guidance and assistance in connecting with campus resources. Please do not give assurances of confidentially. A student who (appears) poses a threat to self or others must be referred for help. Please note that Family Educational Rights and Privacy Act (FERPA) does not prohibit sharing concerns regarding a student's mental health or safety, including their name, with the Counseling Center.

#### **Counseling Center (x2273):**

- If you are connecting with a student remotely and are suggesting that they make an appointment with us, you can encourage them to call the counseling center while you're with them. This way the student knows you are concerned, we know you are concerned, and the likelihood of the student getting intervention is greatly increased.
- Consultation services are available to help make decisions about whether to refer a student to counseling, what steps might be taken, whether it is an urgent concern, and how to proceed. Remember that FERPA only applies to prohibiting the release of information derived from a student's educational records unless it is needed to protect the health or safety of a student. So, please contact us if you have any concerns or questions.
- The situation does not have to be urgent, give us a call and discuss your concerns. We try to track concerns about students, so if we hear from several members of the community, we can respond before a situation becomes a crisis.
- There is an emergency counselor available each day (8:30-5) to provide consultation to the campus community. We provide this service to assist you with any concerns you might have about a student. We try to take calls right away, but if we are with another student, please leave times and numbers at which you can be reached.
- Consider completing <u>Kognito</u>, an interactive program on the Counseling Center website that allows users to learn how to approach at-risk students and make appropriate referrals to campus support services for screening and assessment.

#### **Campus Police (x5911):**

• If a student is threatening you in any way or poses an imminent risk to themselves or others

#### **Dean of Students (x2621):**

• If a student is acting out in a disruptive or bizarre way, please call the Office of the Assistant Vice President for Student Development office (x5646)

#### **Student Support and Wellness Promotion (x2928):**

• Offers individual support services to students who may need assistance with navigating the complexity of college life, are contemplating a medical leave of absence, or who have returned from a medical leave of absence and require support.

#### **Student Health and Education Services (x5055)**

• Provides active promotion, health protection, and disease prevention services for students consistent with the University's educational mission.

# Director of Women's Center and Sexual Violence Prevention, Education, and Response Coordinator (x5844):

- Confidential resource for concerns about sexual assault, dating and domestic violence, emotional abuse, and stalking
- Can provide information regarding options for medical resources, Title IX process, and legal process.

#### Director Title IX Compliance and Assessment (x2763):

• To report a sexual assault, dating/domestic violence, stalking or sexual harassment. Coordinator can provide interim measures such as no contact orders; changes to class schedules; assistance with rescheduling an academic assignment (paper, exam, etc.); tutoring support; changes to work schedules/situations; transportation assistance and escorts to and from campus locations; visa and immigration assistance; medical leave of absence including information on financial impacts; interim suspension for the alleged respondent; and other measures for safety as necessary.

### Disability and Accessibly Services (x2062):

- If student provided an accommodation letter at beginning of semester, and student stops going to class
- If proctoring an exam for extended test taking accommodation and student still needs more time
- If you or student needs clarification about any accommodation (such as, flexibility with class attendance)
- If the student mentions he or she has a disability and would benefit from classroom accommodations
- If you have questions about some behavior in class which might be disability related

#### Academic Advising and Support Center (x5050):

• Academic adjustment student concerns, especially if the student is missing class. Advising and registration support.

#### **The Study (x2104):**

• Peer and professional tutoring, organization and time management coaching, and academic success workshops. The Study is offering meetings and workshops remotely.

#### **Dean of Undergraduate Studies (x5547)**

- Academic policy and implementation concerns
- Other academic concerns. Medical problems or life events are interfering with academics. Seeking an extended excused absence. If a student is acting in a disruptive or bizarre way or has expressed concerning thoughts.

#### **Graduate Student Services (x2353):**

• Advocates for graduate students and offers resources, programs, and information to enhance the graduate student experience.

#### When a student has experienced the death of a loved one:

Whenever you meet or work with a student who is dealing with the illness of a loved one or who has experienced a recent loss, please connect them with one of the following resources:

- Campus Ministry (x2768) will reach out to students to offer both spiritual and personal support. Every student will be invited to solicit prayers and alert the Loyola community about a death in their immediate family.
- The Dean of Undergraduate Studies (x5547) or the Department Chair for Graduate Studies will notify faculty and send an e-mail to the student as appropriate. The Associate Dean or Dean will work to help students talk to their professors about making up missed work and help put academic support in place as needed.
- The Counseling Center will offer personal support and help students explore the ways their situation might be impacting them. When a counselor meets with the student, they will assess any other needs that they may have, and we will offer individual or group support (the Facing Loss group has proven to be immensely helpful to students).
