HOW TO COMPLETE THE STUDENT HEALTH PROFILE ONLINE

1. Scan the QR code to log in to the [Patient Portal](#) using your Loyola University credentials. *Please use Mozilla Firefox or Google Chrome to complete the profile.*
2. On the left-hand menu, click on [Immunizations](#) to:
 - a. Enter the dates when you received the vaccines required by the university. *See on the back of this page a list of required immunizations. Make sure you have your immunization record on hand.*
3. Click on [Uploads](#) to:
 - a. Upload a picture/screenshot/electronic copy of your **official immunization record** (or titer results) acquired from your doctor’s office or health department. *Your name and date of birth must be present and legible on all documentation.*
 - b. Upload a photo of your insurance card (front and back).
4. Click on [Forms](#) to complete:
 - a. Student Health History
 - b. Consent for Treatment
5. **FULL-TIME STUDENTS ONLY:** Click on [Insurance](#) for more information on how to enroll or waive medical insurance coverage in the Student Health Insurance Plan.

IMPORTANT NOTES

- **These requirements are separate from any requirements for other programs such as Athletics, or Nursing.** The information submitted is **not** shared between departments.
- **Students who have already completed these requirements as an undergraduate student do not need to submit another health profile** but should ensure all vaccinations are up to date.

Meningitis (MCV4/ACYW) [Menactra/Menveo/MenQuadfi] The most recent dose must be after the student’s 16 th birthday and within the last 5 years.	Required	*Required (if living on campus) <i>*Graduate students age 22 and older who are not living on campus are exempt. Required for on-campus housing.</i>	Not required
Tdap (Tetanus, Diphteria, Pertussis) Most recent dose within the last 10 years.	Required	Required	Not required

Consent for Treatment	Required	Required	Required
