As NWSA, *Ms.* and the Karson Institute for Race, Peace & Social Justice developed our series on Critical Race Theory (CRT), we reached out to educators and organizers across the country to contextualize the perils of teaching CRT within schools, ranging from kindergarten to college settings. As of September 25, 2021, eleven states —Arizona, Florida, Georgia, Idaho, Iowa, New Hampshire, Oklahoma, South Carolina, Texas, Tennessee, Utah—have passed legislation primarily restricting truthful education and limiting the critical thinking process of students in public schools and higher education. Approximately 24 states have introduced similar legislation, which has been fueled by misinterpretations of the misuse of CRT.

This CRT series will provide you with first-hand accounts and informational tools to understand the tenets of CRT and its proper implementation. Our series topics include: the legal and policy initiatives around CRT, the statewide bans in Iowa, Texas, Tennessee and Utah, school district level restrictions, a government official's perspective on the statewide ban, mothers' understanding of how the legislation limits children's engagement with social justice and the need for children (and adults) to have tools to understand racism, discrimination and other topics that allow for an anti-oppressive education. Additionally, we compiled a CRT annotated bibliography.

Mothers, students, community organizers and legislators come together in our CRT Series to collectively address the landscape of effectively integrating CRT. Coming to terms with the truths and injustices of yesterday and today are necessary to understand how identities are woven into the fabric of our nation's story. We look forward to this journey to justice with you.
